Apprenticeship Support and Knowledge in Schools (ASK)



GMLPN offer a range of inspirational and engaging **impartial Apprenticeship information and support to all schools, colleges and NEET providers in Greater Manchester** for students in years 10, 11, 12 and 13. The aim of the Apprenticeship Support and Knowledge for Schools (ASK) programme is to support educational establishments to deliver high-quality information, advice and guidance (IAG) to their **students on apprenticeships and traineeships**.

GMLPN created a search function that enables young people, parents, careers advisors and teachers to find out which providers deliver which standards in Greater Manchester. Users can search by sector, levels of apprenticeships and by provider. **Listings on the search function are free as part of membership.**

Supporting Autistic Individuals into Apprenticeships

The purpose of this project, delivered in partnership with NCFE, is to **equip autistic individuals with technical and employability skills to progress into Apprenticeships** or other vocational education and training. It aims to improve links between schools/colleges, training providers, referral agencies and employers to **improve progression routes between education and employment.**

Using our local knowledge of Training Providers in Greater Manchester, we are able to identify a provider to support the autistic individual who then can deliver a bespoke package of support. We are also working to support providers, referral agencies and employers via our Autism & Apprenticeships online community. **Get in touch for more information!**

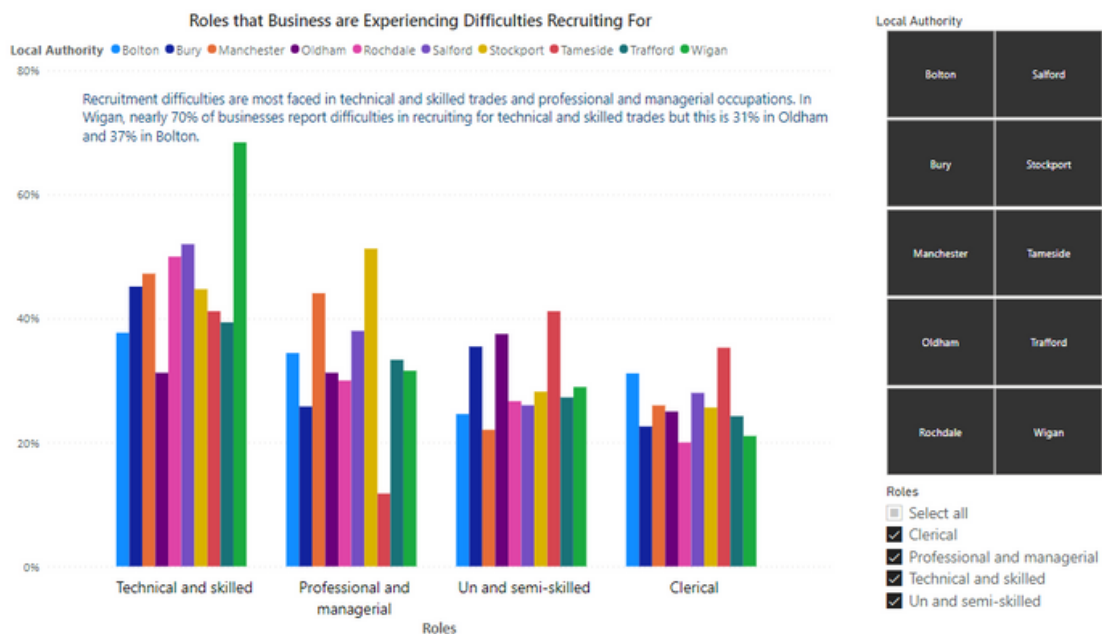
GM BEST



To develop a better understanding of skills related constraints, GMLPN has partnered with Greater Manchester Chamber of Commerce (GMCC) to develop the **GM Business, Employment, Skills and Training Monitor** (GM BEST).

Data has been **collected through surveys** of c.1,100 business across Greater Manchester and **Focus Group** meetings with learning providers.
